**ENTIRE AGREEMENT:** This agreement contains the entire understanding between GAVIN SEIM Photography and the CLIENT. It supersedes all prior and simultaneous agreements between the

parties. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties want to waive one provision of this agreement, that does not mean that any other provision is also waived. The party against whom a waiver is sought to be effective must have signed a waiver in writing.

**RESERVATION:** A signed contract and reservation fee are required to reserve the specified coverage.

**COOPERATION:** The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. GAVIN SEIM Photography recommends that CLIENT designate an "event guide" to point out important individuals for informal or candid photographs to the photographer during the wedding that they wish to have photographed. The photographer will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for photograph's. GAVIN SEIM Photography is not responsible if key individuals fail to appear or cooperate during photography sessions or for missed images due to details not revealed to GAVIN SEIM Photography.

**SHOOTING TIME / ADDITIONS:** The photography schedule and selected methodology are designed to accomplish the goals and wishes of the CLIENT in a manner enjoyed by all parties. CLIENT and GAVIN SEIM Photography agree that cheerful cooperation and punctuality are therefore essential to that purpose. Shooting commences at the scheduled start time.

**HOUSE RULES:** The photographer is limited by the guidelines of the ceremony official or reception site management. CLIENT agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is CLIENT's responsibility; GAVIN SEIM Photography will offer technical recommendations only.

**Photo's:** During the shooting of any images that are arranged, and or posed by GAVIN SEIM Photography, The guests of the wedding may not take any photo's of the pose, subject, or subjects. As the taking of such may cause interference with photography, and breaks the copyright rules of GAVIN SEIM Photography. The client agrees to back the photographers rights, and not allow the taking of such images.

**IMAGES and COPYRIGHTS:** the photographs produced by GAVIN SEIM Photography are protected by Federal Copyright Law (all rights reserved) and may not be reproduced in any manner without GAVIN SEIM Photography's explicitly written permission. Upon final payment by the CLIENT, **limited** copyright ownership of the resulting images Which may be used only for personal use and may not be copied ,or reprinted without express permission of GAVIN SEIM Photography, with exception of hi res "Digital Negatives" disks, with which the owner may make prints for personal use, but may not copy, or distribute the disk in any manner.

The Client must obtain written permission from and compensate GAVIN SEIM Photography prior to the CLIENT or its friends and relatives publishing or selling the photographs for profit.

**MODEL RELEASE.** The CLIENT hereby grants to GAVIN SEIM Photography and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases GAVIN SEIM Photography and its legal representatives and assigns from all claims and liability relating to said photographs.

**LIMIT OF LIABILITY:** In the unlikely event that the photographer is injured or becomes too ill to photograph the event, GAVIN SEIM Photography will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. GAVIN SEIM Photography takes the utmost care with respect to exposure, transportation, and processing the photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond GAVIN SEIM Photography's control, GAVIN SEIM Photography liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.

**SECURITY DEPOSITS:** In the event of cancellation, the security deposit paid is non-refundable. It shall be liquidated damages to GAVIN SEIM Photography in the event of a breach of contract by CLIENT. The CLIENT shall also be responsible for payment for any GAVIN SEIM Photography materials charges incurred up to time of cancellation.

**COMPLETION SCHEDULE:** Printing and/or CD creation takes approximately two weeks

**PAYMENT SCHEDULE:** 50% due at time of signing of agreement. Balance payable in full, two weeks prior to wedding date.
